
### **Camden Highline**

The Camden Highline is our plan for a new park in the sky, linking Camden Town to King's Cross along a disused railway viaduct. It will be a new international visitor destination, estimated to bring 1.3m new visitors and £16m of new spending to the area each year, as well as a high-quality new park and walking route for local businesses and residents.

It's a multi-million pound project, we couldn't deliver it alone. Instead, we're coordinating the local community and using our lobbying experience to make it happen.

#### Camden Collective

Camden Collective is a flexible project, but at its core provides free workspace in vacant buildings for creative start-ups. Since 2009 it has occupied 18 buildings, and grown from a project funded by us to an entirely self-sufficient allied charity, delivering returns to the BID membership at no cost.

Collective helps maintain Camden's reputation as a creative industry cluster, provides passive crime defence and seeds the area with start-ups who grow and collaborate with Camden's existing businesses.
